## Chapter 01 - Institutional Profile/Executive Summary

### 1.1 Introduction

Several Departments and Public Institutions taking charge of the course of realization of law and justice are coming within the purview of this Ministry. Despite the subject which the Ministry has been entrusted with, its scope and extent have been changed from time to time from the inception to date standing apex of the process of law reforms and in facilitating for the process of administration of justice for the sake of general public. The uniqueness of this Ministry is the Chief Accounting Officer holding responsible for two Expenditure Heads of 110 and 228.

The purview of the Ministry includes the implementation of important laws which *inter alia* consist of laws pertaining to matters relating to criminal and as well as the laws conducive to the protection of the civil rights of the entire citizen of the country. The Ministry thus involves in the introduction of new laws and the amendments to the existing laws in line with the contemporary needs of the country. Further, the Legal Draftsman's Department coming within the purview of the Ministry of Justice engages in a formidable task by way of drafting legislation responding to the requests being made by other public institutions while the Attorney General's Department provides legal advice and issue certificate of constitutionality in respect of certain legal matters.

One of the other responsibilities with the Ministry holding accountable is to facilitate for the administration of justice and to protect the independence of the judiciary. The Ministry extends its fullest cooperation to the Judicial Services Commission for the Court Administration. The Ministry of Justice provides 264 Courts and 39 Labour Tribunals in 34 judicial zones already published in the Gazette with necessary infrastructure facilities. In this effort, the Ministry is involving in maintenance of court buildings, renovation and refurbishment and construction of new building on exigencies. The Ministry is also engaged in the provision of residential facilities, construction and maintenance of official residences enabling the judicial officers to discharge their duties with dignity and independence. Moreover, the Ministry is also responsible for the provision of telecommunication and transport for them.

Avoidance of delays in the process administration of justice is prioritized by the Ministry as its one of the responsibilities. In order to cope with backlog of courts cases, there exists an alternative dispute resolution mechanism against the litigation where the Mediation Boards Commission, the Department of Debt Conciliation Board, the International Arbitration Centre etc. coming within the purview of the Ministry play an important role. Scientific evidence testified by the Government Analyst Department are vitally important in assisting the realization of administration of justice.

In an attempt to provide equal access to justice for all citizens, the legal Aid Commission renders a great volume of work specially focusing its attention on the poor who are unable to seek legal redress. The National Authority for the Protection of Victims of Crimes and Witnesses encourages the witnesses to adduce evidence so that the criminals may be convicted based on the evidence. Further, the Ministry takes the charge of administration matters pertaining to Inquirer into Sudden Deaths, Commissioner for Oaths and Sworn Translators.

### **1.3 Main Functions of the Ministry**

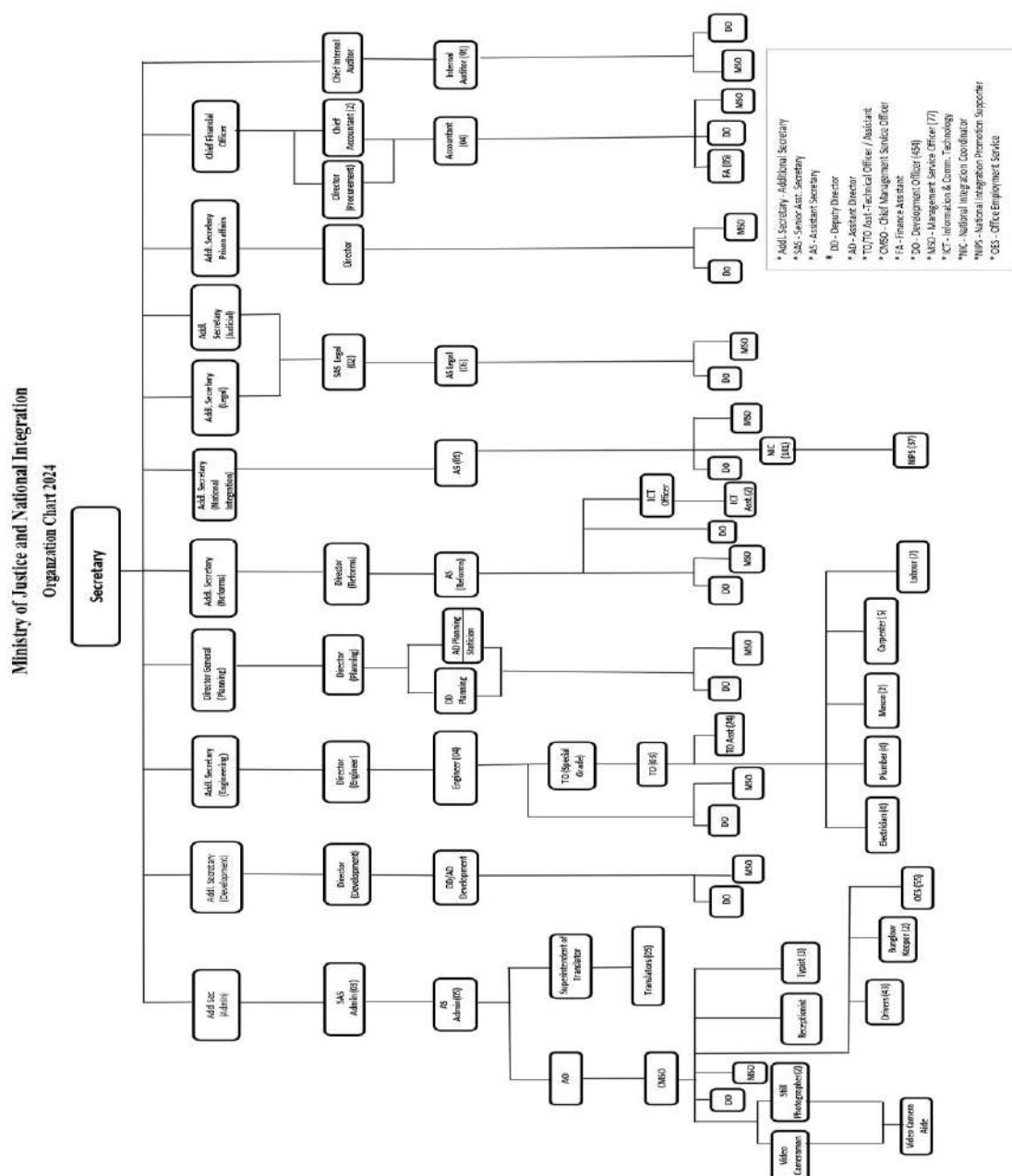

- Provision of public services under the purview of the Ministry in an efficient and people friendly manner.
- Reforming all systems and procedures using modern management techniques and technology, thus ensuring that the functions of the Ministry are fulfilled while eliminating corruption and waste.
- Making necessary reforms required to the legal system taking into consideration social requirements and global trends.
- Re-documentation and consolidation of laws.
- Matters relating to the administration of the courts of justice which have not been assigned to any other party by the Constitution.
- Conducting all activities relating to overall administration, including prevention of law's delays in the courts system, in a methodical and efficient manner, and introduce modern technology for such purpose.
- Criminal prosecutions and civil proceedings on behalf of the government
- Providing legal advice to the government and to all government departments
- Drafting of legislation
- Making recommendations to grant pardons, commutations, remissions, respites and suspensions in relation to sentences passed on any offender.
- Formulation and implementation of an appropriate programme to enhance the effectiveness and efficiency of the overall Quazi system.

- Empowering the Mediation Boards mechanism to resolve civil disputes without resort to the courts

## 2.2 Challenges and Future Goals

The main challenges in the field related to the Ministry of Justice are

- The number of cases pending in the courts
- The acute shortage of human resources that hinders the performance of the institutions
- The Ministry of Justice and its departments and a number of statutory institutions are maintained in rented buildings
- The overcrowding of prisoners in prisons

To overcome these challenges, short-term and long-term programs are being implemented and the plans for the year 2025 are as follows.

### 2.2.1 Legal Reform

### 2.2.2 Infrastructure Improvement

The budget estimate for this year has given priority to expeditiously complete projects currently under construction and to restart projects that were temporarily suspended due to the economic crisis using the allocated funds.

The first phase of the project, which is to modernize the Supreme Court Complex as a grant from the People's Republic of China, has been modernized by the Ministry and handed over to the Court of Appeal. The second phase, which is to renovate the building housing the Supreme Court, has already begun. The construction is scheduled to be completed this year. The total cost estimate for the project is Yuan 230 million.

The Ministry of Justice is currently operating in a rented building. Instead, preliminary work has been carried out to construct a 15-story building for other institutions belonging to the

Ministry on the land acquired for the Justice Piyasa project. As the first phase, work on 10 floors has been commenced in 2025.

In addition, 17 new court building construction projects as consultancy services projects have been temporarily suspended at the planning stage due to prevailing economic constraints. The construction of the Kaduwela and Avissawella projects is expected to commence in 2026, as a priority.

### **2.2.3 Human Resource Development**

The total staff shortage of 6,026 in the courts and all departments and statutory bodies under the Ministry of Justice as well as in the Ministry itself has become a major challenge in the process of delivering justice to all without delay. These requirements have been submitted to the Public Servants Recruitment Review Committee and upon their decision, plans are in place to fill these vacancies.

### **2.2.4 Digitalization of the Judicial System**

Digitalization has been identified by several studies as a fundamental need to make the judicial process efficient. A committee chaired by Hon. Supreme Court Justice Arjuna Obeyesekere has been appointed to implement the “Rapid Digital Strategy” project in collaboration with the Ministry of Digital Economy to establish a judicial system equipped with modern technology. Initially, Kandy and Negombo court complexes have been selected for digitalization as a pilot project and it is planned to commence in 2025.

### **2.2.5 Decongestion of Prisons**

Currently, there are nearly 30,000 inmates in prisons that can accommodate 10,395 inmates. This prison congestion has become a huge cost to the government and a very difficult situation for the inmates. Accordingly, a committee has been appointed to recommend appropriate measures to decongest prisons and rehabilitate drug addicts. Plans have been made to relieve prison overcrowding based on the recommendations of that committee.

### **2.2.6 Strengthening the Alternative Dispute Resolution Process**

Strengthening the Alternative Dispute Resolution Process is a key to reducing the backlog of cases in the courts. More than two hundred thousand disputes are reported to the Mediation Boards per year. Accordingly, it is planned to further strengthen the Mediation Boards and

establish Special Mediation Boards for Land Disputes, which are currently located in 16 districts, in the remaining 09 districts. Similarly, Special Mediation Boards for Financial Disputes are to be established in order to reduce the number of financial disputes referred to the courts. As a first phase, it is planned to establish Special Mediation Boards for Financial Disputes in 6 districts namely Colombo, Gampaha, Anuradhapura, Polonnaruwa, Kandy and Monaragala.

The Department of Debt Relief Board intervenes as an institution that provides legal relief in cases of problems arising from the repayment of loans taken on mortgage of houses, estates or agricultural lands or on a freehold or freehold basis. In addition to the main board, branch boards have been established in the districts of Colombo, Kurunegala, Gampaha and Galle. The next branch is planned to be established in Kandy.

#### **2.2.7 Ensuring equal access to law**

It is planned to further strengthen the services of the Legal Aid Commission operating under 85 Regional Legal Aid Boards. It is planned to open new legal aid centers for Bibila, Kayts, Anamaduwa, Walapane, Gampola and Ruwanwella.

#### **2.2.8 Securing National Integration and Reconciliation**

The Ministry of Justice and National Integration has organized a number of programs in 2025 to create a society that respects all sections of the population, values freedom and equality, with the aim of national unity, national reconciliation and national integration. Accordingly, the Ministry of Justice and National Integration and the departments and institutions affiliated to the Ministry have planned to carry out a great task in the future. I gratefully recall the leadership and guidance of the Honorable Minister of Justice and National Integration, Advocate Harshana Nanayakkara, and the support of the Honorable Deputy Minister of National Integration, M.M.M. Munir Mulafter, to make these efforts successful. I also express my gratitude to the staff of the Ministry of Justice and National Integration who work with great dedication, the heads of departments and institutions affiliated to the Ministry, and the Judicial Service Commission, including the Honorable Chief Justice, who support those staff in decisions related to judicial administration.

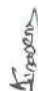

## 5.2 Achievements and challenges in fulfilling sustainable development goals

### ➤ Introduction

The Ministry of Justice and National integration has been entrusted with the 16<sup>th</sup> goal of Peace, Good Governance and Justice out of the 17 sustainable development goals. Furthermore, this ministry has a special role in achieving the goals of Sustainable Development Goals No.5 and 10. Accordingly, a strategic plan was prepared together with



the ministry and its affiliated institutions to achieve sustainable development goals during the period of 2022-2030 and the short-term plan was implemented.

Also, national targets for a number of sub-key indicators including the expected targets to be achieved in the period of 2023-2030 were designed and submitted to the Sustainable Development Council. The Census and Statistics Department has been informed to obtain the relevant data of the indicators that are currently unavailable.

➤ **Achievements**

Under the 16.3.1 the following activities have been carried out by the ministry, Promotion of commercial Mediation (Singapore Convention on Mediation Act for the enactment of United Nations Convention on International settlement Agreements Resulting from Mediation in Sri Lanka)17.04.2024 order published in the gazette.

➤ **Challenges**

01. Difficult to implement the proposed development projects, in the economic crisis which Sri Lanka is facing.
02. Lack of awareness of Public officers, general public and student population, with regard to the Sustainable Development Goals.
03. As executing of sustainable development goals is not a role of the individual institution, assistance of other institutions is constantly needed and it is difficult to make such coordinating activities.
04. Collecting of sufficient data on Sustainable Development concepts , is problematic.
